Lomega Public School Parent and Family Engagement Policy

Part I General Expectations

Lomega School agrees to implement the following statutory requirements:

- Lomega School will put into operation programs, activities, and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with federal regulations.  student academic learning and other school activities, including ensuring

 - c) that parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child.
 - d) the carrying out of other activities.
